

- 50% to the fee on filing of Suit/ Municipal Appeals / Misc. Application / Criminal Cases / etc. (Vakalatnama / Written Statement and Say)
- Remaining 50% of the fee on final disposal of the Suit / Misc. Applications / Criminal Cases / etc.

B. Payment of fees for appeals shall be made in two installments as shown below :-

- 50% of the fee on filing Appeal or reply to Appeal.
- Remaining 50% of the fee on final disposal of Appeal.


C. Payment of fees in Criminal Cases shall be made in two installments as shown below :-

- i) 50% of the fee on filing of complaint or on appearance in case of complaint against NMMC Officers / employees.
- ii) Remaining 50% of the fee on final disposal of the complaint.

D. Payment of fees in Labour / Industrial Court Cases shall be made in two installments as shown below :-

- i) 50% of the fee on filing of complaints, application or reply to the complaint.
- ii) Remaining 50% of the fee on final disposal of the complaint.

This schedule of fee will be applicable to the cases which are filed only after 01/04/2017.
